Footnote # 2: Full membership in the NLAA is mandatory for all license holders and is automatically granted when a license is granted by the Board. The ALBNL collects the NLAA membership fees on behalf of the NLAA.

Footnote # 3: An applicant whose renewal application has been received by the Board no later than 30 November can continue to practise architecture until such time as the Board has decided on the renewal application. If a renewal application is not received by that date, the applicant is required to cease practising architecture on 31 December until such time as the Board has approved the renewal request.

Footnote # 4: The License fee will be pro-rated for a License Holder if s/he applies for Medical Disability, Family Leave or other extenuating circumstances.
